
CERTIFICATION OF A JUVENILE DETENTION FACILITY

After previously adopting the Texas Administrative Code Standards for Facilities Title 37, Chapter 343 pre-adjudication standards promulgated by the Texas Juvenile Probation Commission and having previously approved and adopted local pre-adjudication policy and procedure, the said Judges certify to Bill C. Bristow, Director of Juvenile Services, the Commissioner's Courts of Cooke, Fannin and Grayson Counties, to the Administrative Board and to Juvenile Courts having contractual agreements with the Center that the facility is suitable for the detention of up to 30 children in accordance with the Texas Family Code, Section 51.12 as amended.



CERTIFICATION OF A SECURE POST-ADJUDICATION FACILITY



After previously adopting the Texas Administrative Code Standards for Facilities Title 37, Chapter 343 post-adjudication standards promulgated by the Texas Juvenile Probation Commission and having previously approved and adopted local post-adjudication policy and procedure, the said Judges certify to Bill C. Bristow, Director of Juvenile Services, the Commissioner's Courts of Cooke, Fannin and Grayson Counties, to the Administrative Board and to Juvenile Courts having contractual agreements with the boot camp that the facility is suitable for the custody of up to 61 children in accordance with the Texas Family Code, Section 51.125 as amended.




