8. You are to be in your residence by 8:00pm each evening and are not to leave your residence before 6:00am each morning unless accompanied by your parent or guardian. There shall be no exception to this condition unless you obtain written permission from your Juvenile Probation Officer;
9. Immediately notify your probation officer of any change in residence and telephone number if you, your parent or other eligible person with whom you reside move or intend to move to another county and intend to remain there for a period of at least 60 days.
10. You are to report to the Department of Juvenile Services twice a month or as directed by your Juvenile Probation Officer.
11. Perform 17 hours of Community Service Restitution (CSR) hours by serving not less than 10 hours a month at a community service project approved by said court and designated by the Juvenile Board. Follow all rules and regulations as stated in writing in the Community Service Handbook.
12. Reimburse the County of Grayson, through the Grayson County Department of Juvenile Services, the sum of \$\_\_\_\_, paid as probation fees, payable at \$\_\_\_\_, per month with the first payment due on or before \_\_\_\_\_, 2013; and a like sum due and payable on or before the last day of each month thereafter;
13. Reimburse the County of Grayson, through the Grayson County Department of Juvenile Services, the sum of \$\_\_\_\_, paid as restitution fees, payable at \$\_\_\_\_ per month with the first payment due on or before \_\_\_\_\_, 2013; and a like sum due and payable on or before the last day of each month thereafter;
14. Reimburse the County of Grayson, through the Department of Juveniles Services, the sum to be determined paid as attorney fees. When the sum is determined, an Order Amending Conditions of Probation will be signed and filed advising the respondent and guardian of the total amount to be paid in monthly amounts due and payable on or before the last day of each month thereafter;
15. Reimburse the County of Grayson, through the Grayson County Department of Juvenile Services any professional fees that are acquired during the course of your probationary period. You will be notified by your probation officer of any payment required.
16. You are required to attend any and all activities as set forth by the Grayson County Juvenile Probation Department in regard to your rehabilitation. You will be notified of the scheduled activities that require mandatory attendance which include but are not limited to prison tours, educational lectures, job training programs, substance abuse counseling and family counseling;
17. You are to follow the goals outlined in your Case Plan and Case Plan Reviews as directed by you Juvenile Probation Officer;

18. You are to have no contact, either directly or indirectly with the victims in your case, the victim's family or the victim's property at any time;
19. You are not to possess, exhibit and/or wear any gang related articles including but not limited to, clothing, flags, tattoos, etc.
20. You are not to possess any material related to fire starting, including but not limited to: lighters, combustible fluids, etc.
21. I hereby understand that in the event that my case is transferred pursuant to an inter-county-transfer of probation supervision, the terms and conditions set forth in these conditions of probation may be amended, altered or modified by another juvenile court. I further understand that the probation conditions contained herein that relate to fees or the length of probation term may not be amended altered or modified.

You are hereby advised that THE COURT HAS THE AUTHORITY TO REVOKE YOUR JUVENILE PROBATION FOR VIOLATION OF ANY OF THE CONDITIONS OF JUVENILE PROBATION SET OUT ABOVE.

The Court has placed you on Juvenile Probation, believing that if you sincerely try to obey and comply with the conditions of your probation, your attitude and conduct will improve to the benefit of the public and yourself.
